Under law of May 7, 1873, the number of appointed members of the Board was reduced from 34 to 9. When the law went into effect, 27 members with from 2 to 6 years still to serve, were dropped. Of these, 10 had an opportunity to serve at but one meeting, that of March 11, 1873. The reorganized board first met on July 10, 1873. (*The Alumni Record of the University of Illinois at Urbana*, 1906)

In 1887, trustees moved from appointed by the governor to elected.
Effective January 1, 1996, all trustees are appointed by the governor.
